### A. Avres Main Street Project Update

### **B.** Cobblestone Hotel Update

Trustees received breakdown of building Inspector Craig Brooks time. Gave update on issues that has come up with hotel that needed addressed before they can do final inspections. September 6-8 had interviews for all open positions. Estimated opening date set for first to mid of November.

# C. Kestrel Housing Project

Michael Yerman, reported that there was a problem with the soil so had to pull out and go to La Junta, while they recalibrate the foundations to add more rebar. Recorded the 20-foot utility easement so the utility lines will go run in the easement behind or west of the homes. Trustee Cooper voiced concerns about the forms that have been setting in the sun and rain all this time and plumbers make their measurements from what is set.

#### D. Landfill

Trustees received quotes for rental of landfill scales. Trustee McVey had questions about what the cost would be to purchase scales as was not on the quote and the freight costs if was purchased would they go toward the purchase costs. Trustee Cooper feels quote was a little vague. Discussion on rent/lease or buy, would like to get quotes on a 10X70 new scale for purchase, and all costs associated with setup of scales for next month's meeting.

### Merna McGinnis, Town Manager/ Treasurer

Have started working on budgets for fiscal year 2023, have added 5% for employees' wages, and added 9% for insurance increase.

Trustees received the email from the state on the exemptions on sales of incontinence products and diapers and feminine products starting January 1, 2023. The State is allowing the local entities to adopt if they so choose or not. At this time the trustees agree to not exempt the incontinence, diapers & feminine products. Need to take a look at our taxing resolution and see what it says.

## Heath Piper, Electric Superintendent

In need of a wire puller approximately cost \$4,500.00, asked if Merna could approve as long is under \$5,000.00. Trustee all agreed.

Also, in need of a clay packer for the mini excavator, approximate cost is \$7,800.00 from Bobcat. The cost could be split between the water and electrical departments.

Trustee Cooper made motion to purchase the clay packer \$7,800.00. Seconded by Trustee Wittler.

## Tammy Newman, Town Clerk

Received a letter from the LWCF grant, the town has been selected to receive \$248,000.00, just needs to go through one more signing before it is final. Should hear something in the next few months. Talked to the Gates Foundation, could qualify for \$25,000.00 to help with match for the total project. Received a call from Colorado Health Foundation and they could have up to \$50,000.00 from this year's grants that wasn't used by other grant recipients that could be used as part of money needed to replace swimming pool liner or cash match needed for the total project. They will be getting back to us soon with total fund total. Colorado Health Foundation will help with the community outreach, design and costs.

Mr. Steerman, town attorney didn't like the part in RenoSys quotation about the "measurement part" thinks RenoSys need to come and measure the pool to make sure everything is good.

Ms. McGinnis and Ms. Newman attended a webinar by the Brownfield grant on abatements for grants to abate properties.

Received email for the ARPA dollars needing a signed award terms and conditions agreement, the signed assurance compliance with the title of the civil rights act of 1974 and the budget that the money was spent on by September 30, 2022.

If works well to slow traffic down then can look into purchasing another one for the other end of town. Will need to get approval from CDOT for permanent placement, could call and see if they would give a verbal ok.

Discussion on police positions, salary, sign on bonus and talked about maybe a (2) two-year retention time contract. Background checks, fingerprinting, psychological evaluation.

Mayor Gibson contacted Clay Klipfel and he was ok with the \$5,000.00 sign on/move bonus, had asked for \$85,000.00 yearly, Mayor Gibson countered with \$80,000.00 yearly then Clay Klipfel countered with \$82,000.00 yearly with the \$5,000.00 sign on/move bonus.
