

**RESOLUTION NO. 21-01**

**RESOLUTION PROVIDING FOR THE SCHEDULING  
OF MEETINGS, DESIGNATION OF POSTING NOTICES AND DESIGNATION OF THE  
OFFICIAL NEWSPAPER**

**WHEREAS**, CRS 24-6-402 (2)(c) provided that “a local public body shall be deemed to have given full and timely notice if the notice of the meeting is posted in a designated public place within the boundaries of the local public body no less than twenty-four hours prior to the holding of the meeting. The public place or places for posting such notice shall be designated annually at the local public body’s first regular meeting of each calendar year.”

**NOW THEREFORE BE IT RESOLVED** by the Board of Trustees of the Town of Springfield, Colorado that:

Section 1. A regular meeting shall be held each month of the year 2021 on the second Thursday of the month. Notice of regular meetings shall be posted not less than twenty-four hours prior to the holding of the regular meeting. All regular meetings shall begin at 6:00 P.M.

Section 2. The Board may call special meetings at any time. Notice of special meetings shall be posted not less than twenty-four hours prior to the holding of the special meeting.

Section 3. This resolution also designates that notices of regular and special meetings shall be posted on the front door of the Springfield Town Hall, 748 Main Street, Springfield, Colorado, and on the bulletin board outside the Administrative Assistant’s Office in the Baca County Courthouse, 741 Main Street, Springfield, Colorado for the year 2021.

Section 4. This resolution also designates the Plainsman Herald as the official newspaper for the Town of Springfield, Colorado for the year 2021.

Section 5. This Resolution shall become effective immediately upon its adoption.

**RESOLUTION NO. 21-02**

**A RESOLUTION ESTABLISHING LANDFILL MAINTENANCE FEES**

**WHEREAS**, the Board of Trustees for the Town of Springfield is authorized to set monthly user charge rates and other applicable landfill maintenance related fees by Resolution.

**WHEREAS**, the Board of Trustees finds it necessary to increase the maintenance and tipping fees at the landfill due to increased expenses to bring the landfill into compliance with Colorado Department of Public Health and Environment.

**NOW THEREFORE, BE IT RESOLVED** that effective January 14, 2021 the monthly landfill maintenance charges are as follows:

| (2) All Metered Residential users outside city limits | \$32.00 |
| (3) All Metered Business users within city limits     | \$32.00 |
| (4) All Metered Business users outside city limits    | \$34.00 |

**IT IS FURTHER RESOLVED** that effective January 14, 2021, all non-metered landfill customers must pay tipping fees at the gate as listed:

Cars, Station wagons	\$32.00
Pickups, vans	\$34.00
Trucks or large trailers	\$41.00
Mattresses & Box springs	\$ 5.00 each
Commercial Trucks or Trailers	\$12.00/CU YD
Compacted Trucks	\$20.00/CU YD
Construction Debris (metered or non-metered customers)	\$12.00/CU YD
