
BE IT FURTHER RESOLVED that the Master Fee Schedule is effective upon the date adopted by the Board of Trustees.

BE IT ALSO RESOLVED that a copy of this Master Fee Schedule shall be kept in the Office of the Town Manager and made available for public examination during normal working hours.



**Schedule of Rates:**

**Schedule A: General Service Single Phase Service GS-1**

**Applicable:** To all customers requiring single-phase service where no other rate is applicable. The connected load may not exceed 20 kilowatts.

**Type of Service:** Single phase, 60 cycle, at available secondary voltages. Frequency and voltage shall be subject to reasonable variation.

**Monthly Rate:**

Customer and Meter Charge	\$ 15.00

All KWh	\$0.1374 per kWh

A meter deposit being the higher of \$200.00 or the total of the previous occupant's three (3) times average monthly bill is required

**Schedule B: Residential Service**

**Applicable:** To all residential customers for single phase service where use is for single family domestic occupancy of at least six months per year.

**Type of Service:** Single phase, 60 cycle, at available secondary voltages. Frequency and voltage shall be subject to reasonable variation.

**Monthly Rate:**

Customer and Meter Charge	\$ 9.50

All KWh	\$0.1410 per kWh

A meter deposit being the higher of \$100.00 or the total of the previous occupant's three (3) times average monthly bill is required.

**Schedule C: General Service GS-3**

**Applicable:** To all customers requiring three-phase service where the connected load does not exceed 20 kilowatts.

**Type of Service:** Single phase, 60 cycle, at available secondary voltages. Frequency and voltage shall be subject to reasonable variation.

A meter deposit being the higher of \$200.00 or the total of the previous occupant's three (3) times average monthly bill is required

**Schedule D: General Service-Demand GS-D**

**Applicable:** To all customers whose load requirements exceed 20 kilowatts.

**Type of Service:** Single and three phase, 60 cycle, where available, at available secondary voltages. Frequency and voltage shall be subject to reasonable variation.

A meter deposit of the three (3) times average monthly bill of the previous customer's bill at the same address is required.

**Schedule E: Town Service**

**Type of Service:** Single or Three-phase, 60 cycle, at available secondary voltages. Frequency and voltage shall be subject to reasonable variation.

**Schedule F: Private Area Lights (PAL)**

**Applicability:** To any Customer to light an area of an existing meter service location agreeable to the Board, for which Utility lamps with photocell dusk-to-dawn control will be installed on existing Utility poles.

**Type of Service:** Single-phase, 60 Hertz alternating current, 120 volts, two wire, non-metered.

The monthly charges shall be added to an existing metered account as per Private Area Lights (PAL) contract for service signed by the customer responsible for the metered service payments.

The foregoing rates are subject to the monthly Energy Cost Adjustment clause.

A delayed payment equal to 10% of the total charges will be added to the bill if paid after the fifteenth (15<sup>th</sup>) of the month.

**Energy Cost Adjustment**

**Applicable:** To all rate schedules.

**Monthly Rate is set at:** \$0.005/kWh

- a. The Board of Trustees may increase the ECA from time-to-time when significant revenue changes are necessary because of unexpected increases in the cost of power or other emergencies that are estimated to be greater than a 5.0% deviation in FY power costs budgeted. For 2011 5% of power cost is approximately \$61, 350 so if the projected cost deviation from budget is projected to be greater than this amount then a ECA of about \$0.0055/kWh could be added to the current \$.005/kWh for a new ECA of \$.0105. The \$.0055 additional ECA would add approximately \$3.00/month to an average residential customer's bill.

Non-residential users with non-irrigation monthly water consumption greater than 6,350 gallons per month – the monthly charge shall be calculated as follows:

non-irrigation monthly water consumption in gallons ÷ 6,350 X \$18.00

All non-residential users shall pay an additional service charge per month of 5 cents per 1,000 gallons for each 25 mg/l over 280 mg/l of biochemical oxygen demand (BOD)

All sewer users outside the limits of the Town shall pay 2.0 times the applicable in Town rate.

Residential users \$ 750.00

Non-residential users – the tap fee shall be calculated as follows:

non-irrigation monthly water consumption in gallons ÷ 6,350 X \$750.00

In no case shall the nonresidential user's tap fee be less than \$750.00.
