ITEM 9 MOU Between Town of Springfield and Baca County Commissioners Distribution of CARES Act Funds

DOLA Cares Act funding distribution must be COVID19 related. Springfield will receive \$107,829 and funds to Baca County are \$307,204. We can ask for the town funds, or combine with the county and let the Baca County Commissioners be the governing entity to appropriate the entire funding balance. The money must be allocated by December 31,2020.

Mr. Steerman, Town Attorney, offered clarification on how to list the items for DOLA to decide to appropriate the funds. The total County funds of \$307,204 will be distributed by population to all entities: Vilas, Pritchett, Walsh, Springfield, Campo, Two Buttes. You must document that you were affected by the pandemic and DOLA will make the final determination. Examples: masks, gloves, hand sanitizer, cleaning products, overtime leave, penalties waived due to COVID19, utilities- lack of payment, phone bills, swimming pools opening costs and capacity restrictions, election costs: extra judges, additional expenses for August election, or computers so employees can work from home. There will be less administrative costs if processed through the county. We will revisit this subject next September 2021.

Mr. Davidson is having difficulty hearing our sound system. Mr. Davidson received a statement of account from Town of Springfield, certified, issued by Ms. McGinnis today 7/9/20 but it has no account number on it, and he has nothing that would generate an account with the town. The town owns property by fire station, in town limits, that has not been mowed. He would like the town to mow their own property if they request those in town to mow. The Town purchased a house for taxes that has never been torn down. The town needs to take care of their property. He went to the dump, but was not allowed to unload. The landfill should keep a record of people dumping and track it with a receipt with a heading of the Town of Springfield. He then verified the reading this evening was an ordinance, not the new code book. Time limited. Thank you for coming.

ITEM 17 General Business Discussion on Officers Protection Plan-Axon Body Cameras and Taser's Chief Martin gave a presentation and a slide show promoting the body cameras and the need for the safety of the Police officers.

The entire package is \$51,102. The first year is expensive at \$15,870 with payments for 4 years of \$8,808 that will cover 4 body cameras plus 1 extra/free body camera to be kept in the Police Department, and 4 tasers including docking stations. Axon Star covers 8 thresholds and is a box installed in the vehicle that controls turning on the body camera. Redaction equipment also ordered! The first 11 pages are video, camera, and redactions required by the new Senate Bill 217. We have the ability for real time streaming of incidents till back-up can arrive.

Steve Bush passed the Class D and small systems water/wastewater certification.

We begin working on the Budget in August.

The landfill is having a problem. We need dirt. We may stake out the pit placement and start excavation. Chenoweth Construction is also looking for dirt. Tarps are over \$6000; they are heavy and susceptible to tearing up in the wind. Shingles can be used as cover.

We started the utility disconnects.

We gathered \$45,305 on Sales Tax this month.

Ms. McGinnis asked permission to transfer General Fund \$200,000, Electric Fund 100,000 and Water Fund \$50,000 to Colo Trust to get more interest.

Unanimously approved.

We collected \$22,000 for the hail damage last year. The work and improvements have begun.

We have a Special Election on August 4, 2020 – the UOCAVA's ballots were mailed out. The rest will be mailed Monday, July 13, 2020. We have 927 active voters. The legal notice was sent to the paper.

The transition to becoming the Town Attorney has gone well so far. Resolutions and CCORA requests have been completed.

Police Department - Ms. Martin, Police Chief

Call for service has increased. We took 219 calls for service, that is an increase from 117 last month.
