ITEM 1 Call to Order

Mayor Gibson called the special meeting to order at 4:30 pm.

ITEM 5 Budget

Town Manager asked to pay the loan payment \$13,350 to Colorado Water Resources and Power Development Authority. Trustee Locke made a motion to pay Colorado Water Resources and Power Development, seconded by Trustee Maltbie. Motion carried.

A. General - Revenue

Furniture and telephone: Trustee Locke spoke about the board room desk. The U shape where it is all connected for phone, data, and power; the boat shape is not inviting for the public that attend, and I drew up some plans with a diagonal design including area for electrical wires and electronic attachments. Trustees like the U shape. Trustee Locke will contact Mr. Brett Alton for a bid. We hope this will be in the 2020 budget, but Ms. McGinnis will leave \$6000 in each budget.

Ms. Newman stated that Chief Martin would like to increase police surveillance to \$2500 because they are starting a task force with the Sheriff's Office.

Landfill – Trustee Locke said the closure costs covered in the audit breaks down the \$138000. The estimate of cost for final closure is \$59,198. Current closure and post closure costs were \$16,689. Town Manager McGinnis spoke to Mr. Waller for clarification and will invite him to the next budget meeting to discuss this in addition to the audit report.

Trustee Howard expressed concern with closing our landfill and the state of our town. Ms.McGinnis stated that yard debris can be burned in November and December and again March thru May of each year. Trustee Maltbie has had contractors and residents ask what the options are after closure. Ms. McGinnis said we had 157 pickups last month, which is county-wide number. Ms. McGinnis will check with Mr. McGinnis, Street Superintendent, about the amount of topsoil available at the landfill for site coverage. The landfill is on the agenda for November 12, 2020.

ITEM 6 Executive Session
